Documents to be submitted

Successful PACS in the Draw of Lots will be **required to submit an amount equivalent to 10% of the security deposit, as applicable along with the relevant documents to the concerned office within 7 working days, from the date of intimation.** The mode of submission of the amount to the concerned Oil Marketing Company will be mentioned in the Communication to the successful PACS.

List of Documents

- Notarized Affidavit by the applicant PACS as per format given on portal .
- Proof of Date of registration for PACS (at least 3 years prior)
- Notarized Affidavit by the member of Family Unit - If applicable.
- Resolution from Governing Body/ Managing Body of the PACS authorizing an empowered person for making the application/s on its behalf in compliance of the relevant guidelines.

- Notarized Affidavit from co-owners other than Family Unit - If applicable.
- **Land documents for Godown:** Self-attested copy of documents pertaining to "Ownership" of land for godown in the name of applicant or member of 'family unit' Registered Sale Deed/Gift Deed/Lease Deed (15 years minimum)/ Mutation in Government record.

Commissioning of Distributorship

- The selected PACS (Letter of Intent (LOI) holder)/ Person Authorized by PACS, as applicable would be given training and has to clear pre- commissioning quiz/test by scoring qualifying marks that is 80%. In case LOI holder/ Person Authorized by PACS secures less than 80% marks in the quiz, re-training would be given and re-test conducted.
- Before commissioning, Letter of Appointment would be issued to the selected PACS.

Tenure

The tenure of the HP Gas (HPC) & Bharatgas (BPC) Distributorship shall be for an initial period of **10 years and renewable for every 5 years thereafter, subject to the examination of the performance of the distributorship** by the respective OMC and decision thereon. Tenure of the INDANE shall be 10 years and continue thereafter until determined as per rights mentioned in the distributorship agreement.

PACS as LPG Distributor

Under major initiative, Ministry of Cooperation Government of India has allowed Primary Agricultural Credit Society (PACS) to operate LPG Distributorships. In this regard, Ministry of Petroleum and Natural Gas has issued revised guidelines for selection of dealers for regular & rural retail outlets, as well as unified guidelines for selection of LPG distributorships with effect from 18 August 2023. As per the revised guidelines, PACS have been included under Combined Category (CC) for LPG Distributorship for which they can apply online as per the advertisements issued by Oil Marketing Companies (OMCs).

Why PACS as LPG Distributor?

- Wider Rural Outreach
- Better Connectivity with Villagers
- Establish a Stable Business Model
- Develop PACS as a Multi-Service Center

Eligibility criteria

- Valid Registration as registered under the Co-operative Societies Act 1860 or amended thereafter.
- Registration must be 3 years old from the date of application.
- Owned Godown by PACS for storage of LPGs.
- No dealership in name of employee/ Family members of governing / managing body.

- No charges on members of the Governing Body/ Managing Body/Any such other Body of this Registered Society
- No criminal offences involving moral turpitude and / or economic offences (other than freedom struggle) punishable under Law imposed on any member of Governing / managing body of PACS.
- Resolution from Governing Body/Managing Body authorizing a member to make application/s on its behalf, in compliance to the relevant guidelines of selection
- For any advertised location, one PACS can give only one authorization
- Only regular PACS employees may operate the distributorship. No involvement of Contractual or outsourced employee may be permitted.
- Members of the Governing Body/Managing Body/Any such other Body of this Registered Society who has been terminated for malpractices and / or for violations of provisions of the Marketing Discipline Guidelines should not be signatory to dealership/distributorship agreement of any PSU Oil Company.

Procedure to Apply

All Primary Agricultural Credit Society (PACS) as applicable, desirous of applying shall submit their applications through web portal in online mode

Steps involved in Application :

- Step : 1 Register PACS with Portal

Step : 5 Fill the application form
Step : 6 Make online payment

Mode of Selection

Selection for LPG Distributorship will be made by inviting applications through Advertisement/ Notification under appropriate category in newspapers. The details of the locations advertised will be available at the portal <https://www.lpgvitarakchayan.in.>

Selection of PACS will be made on draw of lots based system.

Procedure for Draw of Lots

1. Information Distribution:

- Sent to eligible candidates via email/SMS.
- Includes venue, date, and time for the draw of lots for the LPG Distributor selection.

2. Attendance and Verification:

- Recording of attendance.
- Verification of identity proof.
- Applicants must sign the attendance sheet.

3. Draw of Lots:

- Conducted in the presence of only available eligible candidates.
- Videography of the lottery process will include:
 - a. List of eligible candidates with application numbers.
 - b. Details of the successful candidate displayed on the screen and captured.
 - c. Details of the successful candidate with serial number and name, displayed on the screen and captured by the video camera.
